Author Guideline

The journal publishes original scholarly works intended for first publication. No secondary publication is possible.

1. The sections of the journal

The journal publishes manuscripts in the following sections:

- *Studies*
- *Legal Practice*
- *Review*

The *Studies* section publishes longer manuscripts written with scientific requirements. Manuscripts submitted to the *Studies* section must be at least **1 author's sheet** (40,000 characters) and no more than **2 author's sheets** (80,000 characters) in length.

The *Legal Practice* section provides an opportunity to present significant decisions made by domestic, foreign, and international judicial forums. Manuscripts published in the *Legal Practice* section must not exceed **1 author's sheet** (40,000 characters) in length.

The *Review* section publishes book reviews and critiques of Hungarian and foreign-language publications, as well as presentations of current domestic and international legislation. Manuscripts intended for this section must be at least **one-quarter of an author's sheet** (10,000 characters) and no more than **1 author's sheet** (40,000 characters) in length.

2. Format of manuscripts

Manuscripts intended for publication in the journal should be prepared in accordance with the following editorial requirements:

- The author's name should be written in Times New Roman font, small capitals, bold, size 12, and centred.
- The title of the manuscript should be written below the author's name, in both Hungarian and English, in Times New Roman font, bold, size 12, and centred.
- Below the title, please include a brief abstract, summarizing the content of the manuscript. Each abstract must be at least three sentences long.
- Below the abstracts, list the main keywords related to the manuscript in both Hungarian and English.
- The text of the manuscript should be written in Times New Roman, size 12, with single line spacing, standard margin settings, justified alignment, without word hyphenation or the use of headings. Paragraphs should not be indented; instead, use a single "enter" keystroke to indicate paragraph breaks.

- Use italics only for quoted text within quotation marks.
- Underlining should not be used in the text.
- Personal names in the text should be written in small caps on their first mention (e.g., VÉKÁS LAJOS). Subsequent mentions should use regular font style (e.g., Vékás Lajos).
- The structure used in the text should have a maximum of three levels (e.g., 1.1.1.), formatted as follows:

2.3.1. Proof of Assignment

- Chapter titles should be left-aligned.
- Please use footnotes numbered with Arabic numerals as references, rather than endnotes. Footnotes should be written in Times New Roman, size 10, with single line spacing, justified alignment.
- Quoted text placed within quotation marks should not be broken in either the main text or footnotes. At the beginning and end of a quote, we use typographic quotation marks: thus, “quote” and not "quote".
- A single quotation mark can be used to highlight a word used in a specific sense or a foreign word, e.g., ‘law and order’.

3. Reference Technique

The first footnote inserted after the author's name contains the author's title and institution.

Please use the following reference technique in footnotes.

For all references:

- The last name and first name should be highlighted in SMALL CAPS.
- The order of names should remain as in the original, depending on the language of the publication:
BURAI-KOVÁCS JÁNOS (Hungarian edition)

JÁNOS BURAI-KOVÁCS (foreign language edition)
HELMUT KOZIOL

- After the author's name, please use a colon (e.g., MARTON GÉZA: ...).
- Do not use any specific symbols (e.g., "o.", "p.", "pp.") after the page number(s).

In the case of referencing the same page of a previously cited work – if the same work appears in the next footnote as well – the page number should be indicated again as follows:

Reference to Constitutional Court decisions:

The Constitutional Court decision does not need to be indicated in a separate footnote, it can be included in the text: [15/2023. (VII. 24.) AB határozat]

In the case of repeated references, the author may also indicate the decision in abbreviated form in the text: ABH 1. Indokolás [33]

4. Bibliography

At the end of the study, please provide a bibliographic index of the sources used under the heading "Bibliography." Both foreign-language and Hungarian-language sources should be included."
